 - c. A reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. 'including' is understood to mean 'including without limitation';
 - e. Reference to any statutory provision includes any modification or amendment of it;
 - f. The headings and sub-headings do not form part of this privacy policy.

Scope of this Privacy Policy

- 3. This privacy policy applies only to the actions of Grotech Data Solutions Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to websites or social media websites.

Data that is collected automatically

Who we share Data with

11. We may share your Data with our employees, agents or professional advisors to further any enquiries that you may make via the Website and in each case, in accordance with this privacy policy.

Keeping Data Secure

- 12. We will use technical and organisation measures to safeguard your Data, for example we store your Data on secure servers.

Data Retention

Your Rights
